A 4% surcharge is added on all credit card payments. This surcharge is not greater than our total cost of accepting credit cards.

By participating, you agree to the following terms for entrance into the Madison County Craft Festival.

1) Only specified foods may be sold unless other arrangements are made with the Madison County Craft Festival committee in advance. It is understood that Madison County Historical Society limits competition between food vendors by not permitting two vendors to sell the same food item. However, everyone is welcome to sell water, soda, or bottle drinks.

2) The vendor agrees not to start dismantling his/her booth prior to the closing of the event at 5 pm on Saturday and 4 pm on Sunday unless allowed earlier by show organizers.

3) The vendor shall indemnify and hold harmless the Madison County Historical Society from all loss, cost, or damage and all other liabilities occasioned within the Society's property, caused by any act or omission, neglect or wrongdoing of the exhibitor, or his/her agent, family or representatives. The vendor shall be responsible for and carry adequate insurance to cover all risks.

4) If the vendor requires electricity, the vendor is expected to bring their own extension cords. We suggest a minimum of 50'. Only heavy-duty, outdoor approved, SL, SJ, or SO electrical cable is permissible for extension cords. (The Oneida City Fire Marshall will be around to inspect and will not permit any other type of electrical cords.) No electrical octopus outlets can be used. No splices or electrical wires are permitted.

5) The vendor releases to MCHS the use of any photograph or film media that they or their authorized staff may take for promotional purposes at the Madison County Craft Festival.

Set-up Friday, Sept. 11 from 10 am- 6 pm. Arrangements must be made in advance for set-up at other hours. If you are unable to set up at this set time, please contact the society immediately to make other arrangements.

- The historical society is located on the corner of Main and Grove Street. When you come to set up you will see orange construction fencing enclosing the grounds. Please turn down Grove Street and enter the side driveway there. Once you enter there will be a registration area set up where you can pick up your show materials.
- Please feel free to ask the volunteers any last-minute questions that you may have about the show.
- Coffee and donuts are served each morning to all participating in the show. Please note that all vehicles must be removed from the property after unloading on Friday. There is limited street parking over the weekend.
- There is overnight parking available at Maxwell Field located on East Sands Street. Participants in the show should not park on the streets surrounding the grounds during the show as these spaces should be left open for customers. No smoking is permitted on the grounds.

Security: MCHS will provide a security guard from 7 pm Friday and Saturday nights until 7 am on Saturday and Sunday morning.
